## **Approved Certifiers List**

Below is a list of persons who may certify documents.

#### General

- Commissioner for Affidavits
- Commissioner for Declarations
- Justice of the Peace

#### **Banking and Post Office Services**

- Permanent employee of Australian Postal Corporation or a Commonwealth, State, or local Government authority with 2 or more years of continuous service who is employed in an office supplying postal services to the public
- Banking/Building Society/Credit Union/finance company officer with 2 or more continuous years of service

#### **Legal and Courts**

- A person who is enrolled on the role of the Supreme Court of a State or Territory, or the High Court of Australia, as a legal practitioner, (however described)
- Chief Executive Officer of a Commonwealth Court
- Clerk of a court
- Judge of a Court
- Magistrate
- Registrar, or Deputy Registrar, of a Court
- A person who, under the law in force in a State or Territory, is currently licensed or registered to practice as:

Chiropractor
Dentist
Legal Practitioner
Nurse
Psychologist
Veterinary Surgeon
Pharmacist

#### **Accounting and Taxation Services**

- Fellow of the National Tax Accountants' Association
- Member of Chartered Secretaries Australia
- Member of the Association of Taxation and Management Accountants
- Member of the Institute of Chartered Accountants in Australia, the Australian Society of Certified Practising Accountants or the National Institute of Accountants

#### **Defence and Protection Services**

- Member of the Australian Defence Force who is:
  - An Officer; or
  - Non-commissioned Officer within the meaning of the Defence Force Discipline Act of 1982 with 2 or more years of continuous service; or
  - A Warrant Officer within the meaning of the Act
  - Police Officer
  - Sheriff or Sheriff's Officer

#### Other Services/Roles

- Marriage celebrant registered under Subdivision C of Division 1 of Part 4 of the Marriage Act 1961
- Member of:
  - The Parliament of the Commonwealth; or
  - The Parliament of the State; or
  - A Territory legislature, or
  - A Local Government Authority of a State or Territory
- Minister of religion registered under Subdivision A of Division 1 Part 4 of the
- Marriage Act of 1961
- Notary Public
- Teacher employed on a full-time basis at a school or tertiary education institution
- An officer with, or an authorised representative of, a holder of an Australian financial services licence or an
- Australian Credit licence, with 2 or more years of continuous service with one or more licensees.

#### **Approved Overseas Certifiers**

- Employee of the Australian Trade Commission who is in a country or place outside Australia; and under paragraph 3 (d) of the Consular Fees Act of 1955; and exercising his or her function in that place
- Employee of the Commonwealth who is in a country or a place outside of Australia and authorised under a paragraph 3 (c) of the Consular Fees Act 1955; and exercising his or her function in that place
- Australian Consular Officer or Australian Diplomatic Officer (within the meaning of the Consular Fees Act 1955)
- A person in a foreign country who is authorised by law in that jurisdiction to administer oaths or affirmations or to authenticate documents.

# What do the above authorised officers need to do to certify your documents?

An Authorised Officer (certifier) should do the following in the presence of the applicant:

- Certify that each document is a true copy of the original.
- Certify that the photograph if provided (e.g. licence or passport) is a true likeness of the applicant.
- Witness the signature of the applicant

### Certified documents must be completed in Pen and:

- Be initialed on every page by the Authorised Officer (certifier)
- Be annotated on the last page as appropriate e.g. "I have sighted the original document and certify this to be a true copy of the original" and signed by the Authorised Officer.
- List the name, date of certification, and contact phone number and position number (if relevant)
